



- ❖ All enrollment completed and Childcare can be set. Spaces can be set after enrollment fee
- ❖ All payments your enrolling for 9am – 2.30pm school day, your monthly tuition is due no later than June 5th, 2020.
- ❖ Extended Care can be paid weekly and is added to the school day monthly cost. **No credit will be given if you miss a day/week.**
- ❖ Extended Care payment is considered late Friday at 5:35pm a \$5/day late fee will immediately go into effect until payment is made. Termination of care after 10 days of nonpayment.
- ❖ We accept Cash, Check (no fee's) and Credit Cards (Square and PayPal charge us fee's which are passed onto the customer). Any returned checks are subject to a \$25 fee that our bank charges plus any other fees incurred and you may then be required to pay Cash or Credit Card.
- ❖ When our summer program is full you have the option to be added to our wait list. Please return your enrollment paperwork timely to avoid disappointment. Guaranteed Enrollment ends 5.1.2020. We operate on a first come first served basis.
- ❖ "DROP IN" can be arranged outside of your schedule if the need arises. Additional charge.
- ❖ Hours of Operation: You can choose 8am or 9am – 2:30pm or 5:30pm. Choice of 2,3,4 or 5 days/week.
- ❖ If you pick up past 2:35 or 5:35pm a \$1/minute late pick up fee will be assessed.
- ❖ We provide a morning and afternoon snack; you will still send a lunch each day. If your child has a food allergy you are required to send a snack for them.
- ❖ Please do not send a sick child to school – our illness policies are observed during the summer.
- ❖ Please label all items you send to school; we cannot be responsible for lost items. Please send an extra set of clothes each day for your child to change into if they get wet, a towel is handy too. No swimsuits this year please. Children must have a change of clothes to participate.
- ❖ Please send a nap mat and blanket if your child naps
- ❖ The following rules pertain to Bethany Bridges Club Inc. business policies. These policies are nonnegotiable. Bethany Bridges Club Inc. reserves the right to terminate care at any time for any sufficient reason, including but not limited to: the program not being a good fit for the need of the child/family, late or non-payment, misbehavior or unruliness of child.
