

LIABILITY WAIVER AND RELEASE OF ALL CLAIMS

In these uncertain times, WE, at Bethany Bridges, are resolute in our care for and devotion to your children and our collective calling to ensure their safety and development. Our organization will attempt to use best efforts to adhere to guidance/standards from health professions to maintain a safe facility and provide a positive experience for our students.

HOWEVER, WE SPECIFICALLY ACKNOWLEDGE THAT NO ONE CAN PROMISE OR PROVIDE AN ENVIRONMENT FREE OF OR IMMUNE TO COVID-19.

Therefore, in consideration of participation in Bethany Bridges, I/We, on behalf of myself and any minor child/children for whom I have the capacity to contract, hereby acknowledge and agree to the following:

I understand the potential hazards of the novel coronavirus (“COVID-19”) and am familiar with the Centers for Disease Control and Prevention guidelines regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing daily and that CDC guidelines are regularly modified and updated. I accept full responsibility for familiarizing myself with the most recent updates and making an informed decision for my child/children. Notwithstanding the risks associated with COVID-19, which I hereby readily acknowledge, I hereby willingly and knowingly choose to participate in Bethany Bridges.

I acknowledge and fully assume the risk of exposure, illness and/or death related to COVID-19 arising from my or my child’s presence at Bethany Christian Church and/or participating in Bethany Bridges. I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and/or any minor child for whom I have the legal ability and capacity to contract) Bethany Christian Church, Bethany Bridges, their owners, officers, directors, elders, employees, agents, heirs, personal representatives, volunteers and assigns (the “Released Parties”) from any liability related to COVID-19 which might occur as a result of my or my child’s being on premises and/or participating in activities.

I shall indemnify, defend and hold harmless the Released Parties from and against any and all claims, demands, suits, judgments, losses, services, medical liens, or expenses of any nature (including without limitation, attorneys’ fees, costs and disbursements) arising from or out of or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.

It is my express intent that this Waiver shall bind any assigns and representatives, and shall be deemed a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named Released Parties. This Agreement shall be construed, interpreted and controlled according to Oklahoma law. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND THAT CONSIDERATION FOR THIS AGREEMENT WAS PERMISSION TO BE ON PREMISES AND PARTICIPATE IN BETHANY BRIDGES ACTIVITIES. _____ (initial)
